

American Data Group Inc. 2025 Payroll Tax Rates

To create your 2025 tax tables (if not already done), use the Clone feature as follows:

- Go to Payroll File Maintenance > Taxes Master
- Click on the asterisk (*) and select "Clone All Tax Tables from 2024"
- On the next screen, New Payroll Year = 2025 and then click Clone * Please note "Overwrite Existing Tax Type Records" can be used if running the Clone Tax Tables program again to correct errors from a previous clone.
 - When the process completes, Select Payroll Year = 2025 to view the new year.

Edit 2025 tax table codes as follows:

FICA Employee – The Maximum Earnings field changes to **\$176,100**. The value is **.0620** and 'Flat Value is Percentage' must be checked.

FICA Employer – The Maximum Earnings field changes to **\$176,100**. The value is **.0620** and 'Flat Value is Percentage' must be checked.

Medicare Employee – No changes are needed. The Maximum Earnings field should be **\$9,999,999.99**. The value is **.0145** and 'Flat Value is Percentage' must be checked.

Medicare Employer – No changes are needed. The Maximum Earnings field should be **\$9,999,999.99**. The value is **.0145** and 'Flat Value is Percentage' must be checked.

Medicare Employee Surcharge – No changes are needed. The Minimum Earnings field is **\$200,000** and Maximum Earnings **\$9,999,999.99**. The value is **.009** and Flat Value is Percentage.

State and Local Taxes – State and local tax changes are not provided. Check with your state for any changes and enter them into the appropriate tax table code. An additional Head-of-Household table is now available if needed.

Federal Withholding – The Withholding Allowance is **\$4,300** for W4 forms filed prior to year 2020. The six 2020 tax tables are shown below.

Maximum Employee 401K contribution \$23,500. 50+ catch-up is an additional \$7,500. The IRS has introduced in 2025 a catch-up amount of \$11,250 if you are between 60 and 63.

Maximum HSA contribution is \$4,300 for Single, and \$8,550 for Family. 55+ Catch-up is \$1,000.

Maximum Dependent Care contribution is **\$5,000**.

Maximum FSA contribution is **\$3,300**.

The tables below are for Pre 2020 W4 forms and those **not** selecting Step 2c on the 2020 W4 form.
